The right of way to be established and acquired for this improvement is depicted as Rockhouse Road in Appendix "A".

WHEREAS establishment and acquisition of the right of way is necessary for the realignment and improvement project of a portion of U.S. Route 191; and

WHEREAS because of these premises, this Board finds public safety, necessity and convenience require the recommended establishment and acquisition of the additional land needed for this improvement; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

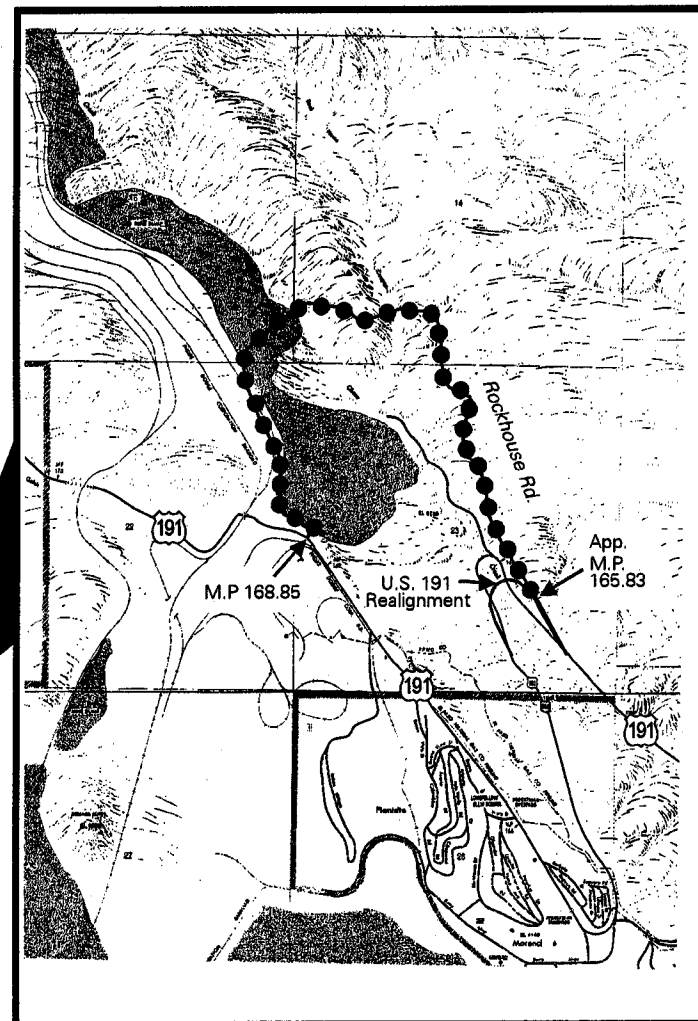
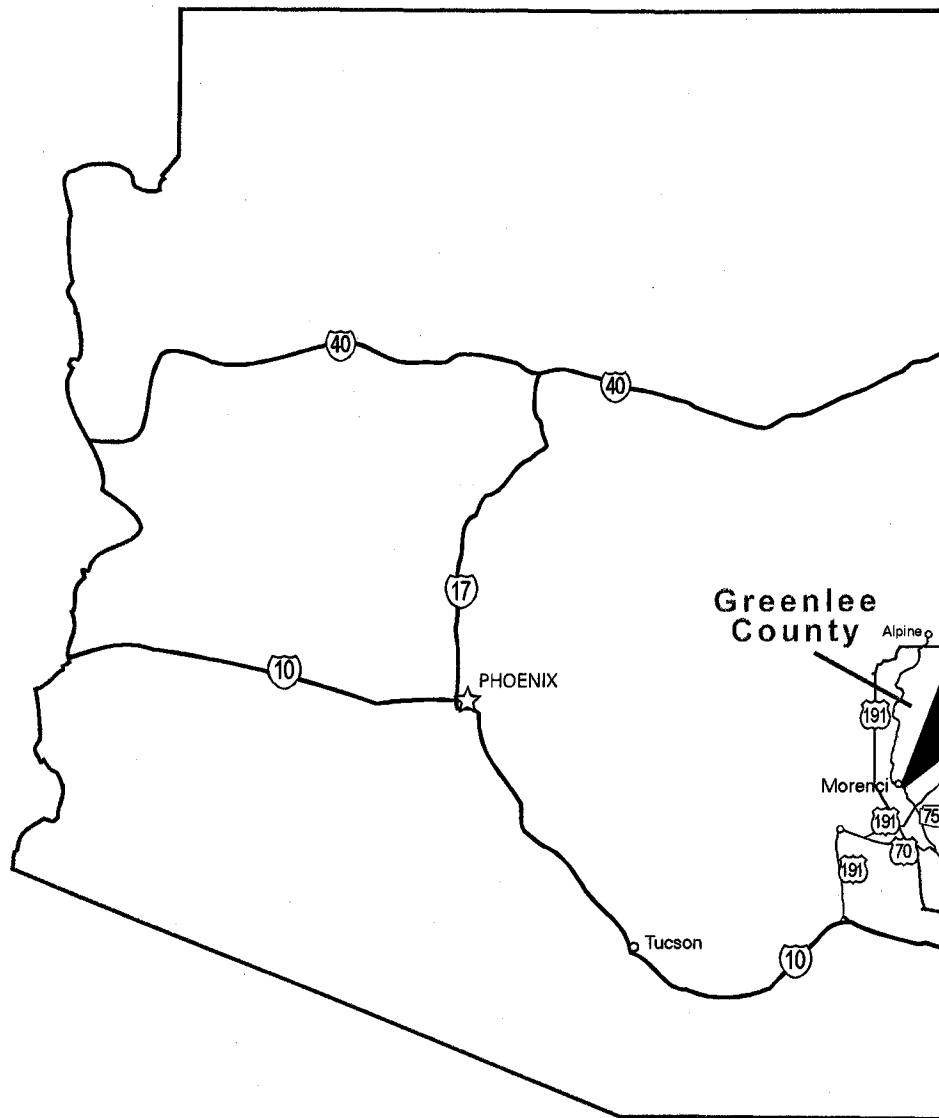
RESOLVED that the portion of right of way as depicted in Appendix "A" is hereby designated a temporary detour state route and state highway; be it further

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the establishment and improvement of a portion of Rockhouse Road as a temporary detour state route and state highway within the above referenced project.

Improvements and realignment of U.S. Route 191 are to be constructed within the above referenced project. During the construction period, it will be necessary to establish a temporary detour route to accommodate through traffic. Accordingly, it is necessary to establish and acquire the existing Rockhouse Road as a temporary detour state route and state highway.

The additional right of way to be established and acquired is depicted as Rockhouse Road, in Appendix "A".

In the interest of public safety, necessity and convenience, I recommend that the area depicted as Rockhouse Road, in Appendix "A" be established and improved as a temporary detour state route and state highway, to be extinguished and disposed of upon completion of the improvement project by a subsequent Arizona Transportation Board Resolution.


I further recommend the acquisition of Rockhouse Road as a temporary detour state route and state highway.


