RESOLUTION OF ABANDONMENT

MARY E. PETERS, Director, Arizona Department of Transportation, on July 16, 1999, presented and filed with this Transportation Board her written report under Arizona Revised Statutes Section 28-7046, recommending the abandonment of a portion of State Route 89 within the above referenced project.

The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, WICKENBURG - PRESCOTT Highway, Project F-025-1-725 / 089YV312H306401R."

WHEREAS said portion of right of way is no longer needed for state highway purposes; and

WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

RESOLVED that the portion of right of way depicted in Appendix "A" is hereby removed from the State highway system and abandoned to the City of Prescott as provided in Arizona Revised Statutes Section 28-7207 and 28-7209; be it further

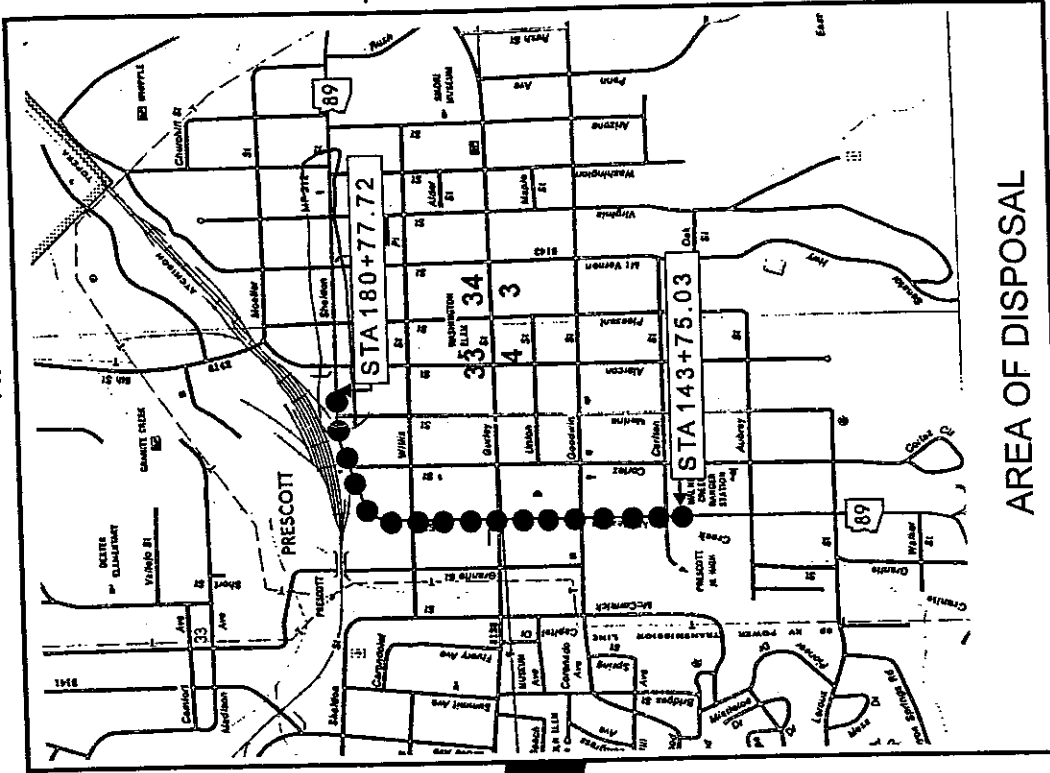
RESOLVED that the Director provide written notice to the City of Prescott evidencing the abandonment of the State's interest.

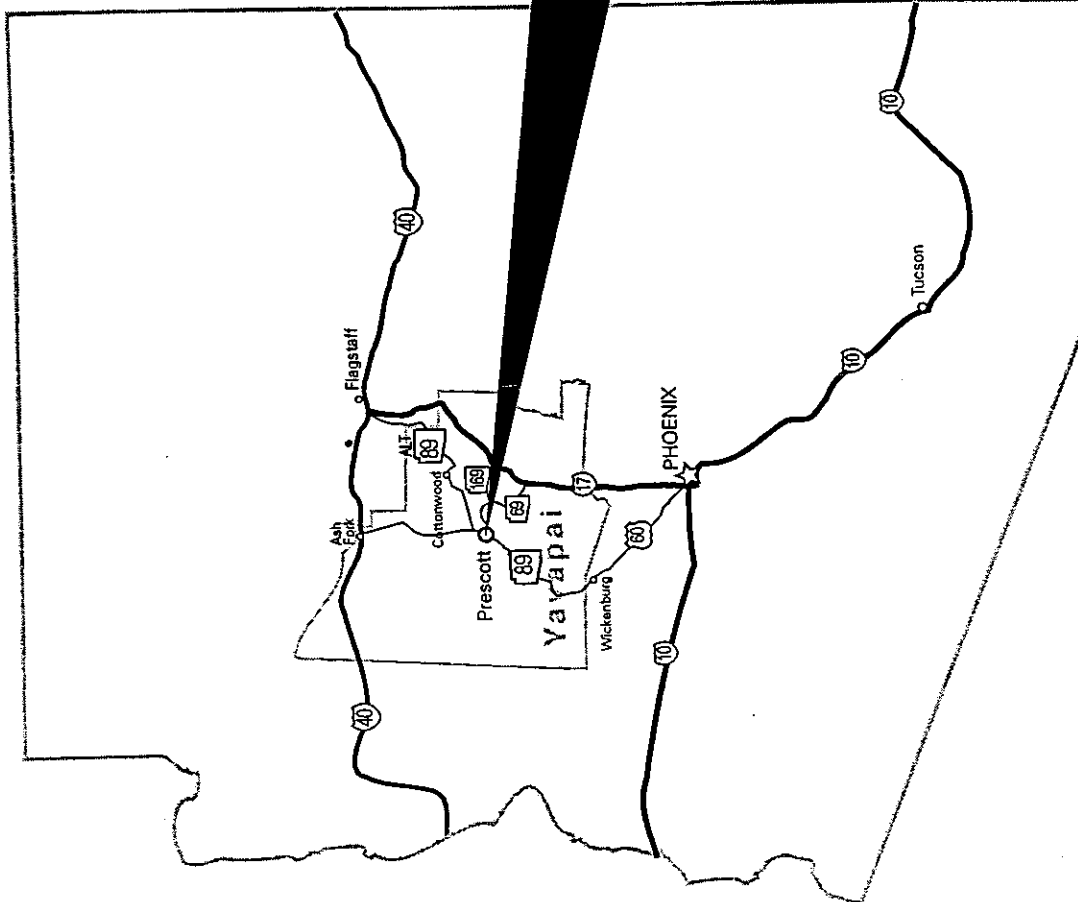

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of a portion of the right of way acquired for State Route 89 within the above referenced project. This portion was previously established by Arizona Highway Commission Resolution dated May 8, 1936 in the Official Minutes, pages 577 and 578 as a state route; Resolution dated May 19, 1936 and May 20, 1936, page 625, as a state highway; Resolution 70-26, dated February 27, 1970 redesignated State Route 89 to U.S. Route 89T; Arizona Transportation Board Resolution 74-4-A-06, dated August 9, 1974, redesignated U.S. Route 89T to U.S. Route 89; and thereafter, Resolution 92-08-A-56, dated August 21, 1992 redesignated to State Route 89.

A portion of the previously acquired right of way is no longer needed for state transportation purposes. The City of Prescott has agreed to accept jurisdiction of the right of way. Accordingly, I recommend that the State's interest in the portion of right of way be abandoned.

The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on the maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, WICKENBURG - PRESCOTT Highway, Project F-025-1-725 / 089YV312H306401R."

I further recommend that the portion of right of way depicted in Appendix "A" be removed from the State Highway System and abandoned to the City of Prescott.
