RESOLUTION FOR HISTORIC ROAD DESIGNATION

MARY E. PETERS, Director, Arizona Department of Transportation, on July 13, 2001, presented and filed with this Transportation Board her written report recommending that State Route 288 and Forest Road 512 be designated Scenic Road "Desert To Tall Pines".

WHEREAS the above referenced state route to be designated Scenic Road "Desert To Tall Pines" is a state highway; whereas the above reference forest road to be designated Scenic Road "Desert To Tall Pines" is a forest road; and

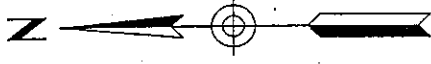
WHEREAS the Parkways, Historic and Scenic Roads Advisory Committee has recommended to the Director that State Route 288 and Forest Road 512 depicted in Appendix "A" be designated a Scenic Road; and

WHEREAS because of these premises, this Board finds that public convenience will be served by accepting the Director's recommendation; therefore be it

RESOLVED that the recommendation of the Director is adopted and made a part of this Resolution; be it further

RESOLVED that State Route 288 and Forest Road 512, as depicted in Appendix "A", be designated a Scenic Road as defined in Arizona Revised Statutes Section 41.512(2); be it further

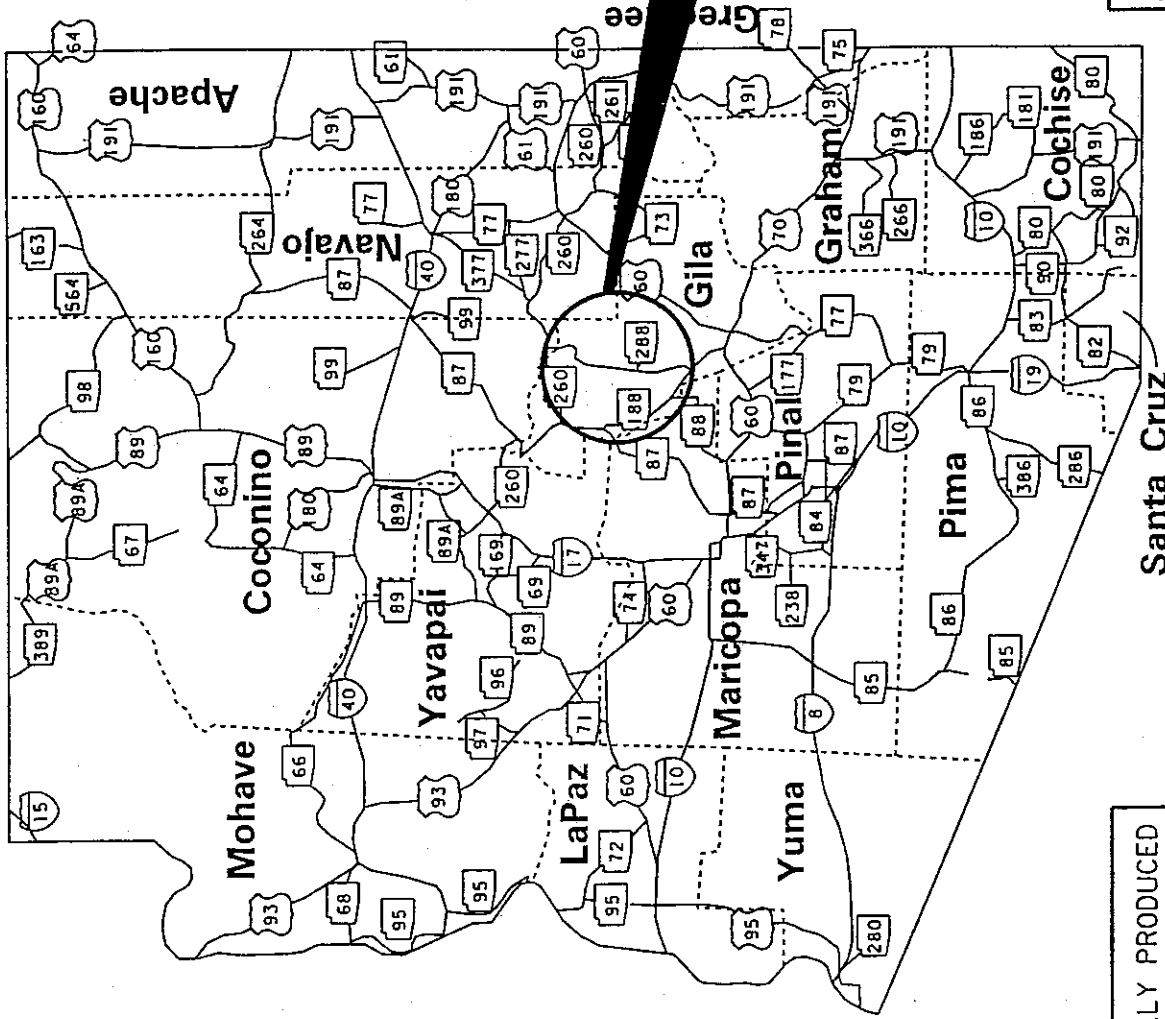
RESOLVED that this Scenic Road be designated Scenic Road "Desert To Tall Pines".

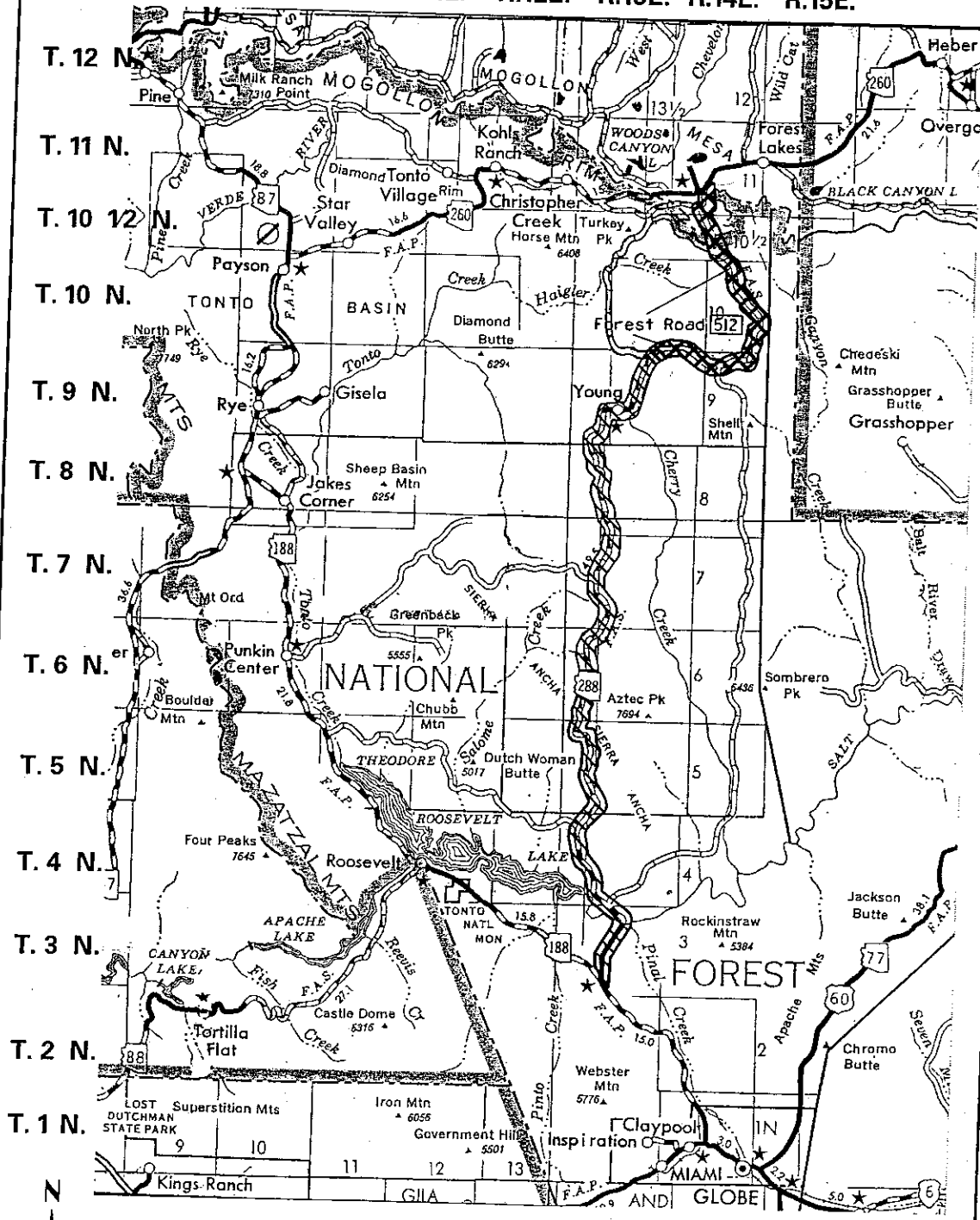

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Parkways, Historic and Scenic Roads Advisory Committee, established under Arizona Revised Statutes Section 41-514 and acting in compliance with Rule R17-3-804, has made a thorough investigation concerning the designation of State Route 288 and Forest Road 512 as Scenic Road "Desert To Tall Pines".


State Route 288 was previously established as a state route by Arizona Highway Commission Resolution 59-78, dated February 17, 1959; Resolution 60-7, dated July 7, 1959 established said route as a state highway; thereafter various Resolutions established additional right of way for improvements thereof.

The Advisory Committee in conjunction with Tonto National Forest and Apache-Sitgreaves National Forest has recommended that State Route 288 and Forest Road 512 be designated Scenic Road "Desert To Tall Pines" as depicted in Appendix "A".

In the interest of public convenience and in concurrence with the Advisory Committee, I recommend that the above referenced state highway and forest road, as depicted in Appendix "A", be designated Scenic Road "Desert To Tall Pines.

Pursuant to Arizona Revised Statutes Section 41-514D, I recommend the adoption of a resolution making this recommendation effective.


