RESOLUTION OF ABANDONMENT

VICTOR M. MENDEZ, Director, Arizona Department of Transportation, on October 19, 2001, presented and filed with this Transportation Board his written report under Arizona Revised Statutes Section 28-7046, recommending the abandonment of a portion of State Route 89 within the above referenced project.

The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, WICKENBURG - PRESCOTT Highway, Project F-025-1(MISC) / 089YV310H088801R."

WHEREAS said portion of right of way is no longer needed for State highway purposes; and

WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

RESOLVED that the portion of right of way depicted in Appendix "A" is hereby removed from the State Highway System and abandoned to the City of Prescott as provided in Arizona Revised Statute Section 28-7207 and 28-7209, and effective upon recordation in the Office of the County Recorder in accordance with Arizona Revised Statute Section 28-7213; be it further

RESOLVED that the Director provide written notice to the City of Prescott evidencing the abandonment of the State's interest.







REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of a portion of right of way acquired for State Route 89 within the above referenced project.

This portion was previously established as a state route, designated U.S. Route 89 by Arizona Highway Commission Resolution dated May 8, 1936, pages 577 and 578 of the Official Minutes; Resolution dated May 20, 1936, page 625 of the Official Minutes, established said route as a state highway; Resolution 70-26 dated February 27, 1970, redesignated U.S. Route 89 to U.S. Route 89T; thereafter Arizona Transportation Board Resolution 92-08-A-56, dated August 21, 1992, redesignated U.S. Route 89T to State Route 89.

A portion of the previously acquired right of way is no longer needed for state transportation purposes. The City of Prescott has agreed to accept jurisdiction of the right of way. Accordingly, I recommend that the State's interest in the portion of right of way be abandoned.

The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on the maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, WICKENBURG - PRESCOTT Highway, Project F-025-1(MISC) / 089YV310H088801R."




