RESOLUTION OF ABANDONMENT

VICTOR M. MENDEZ, Director, Arizona Department of Transportation, on August 16, 2002, presented and filed with this Transportation Board his written report under Arizona Revised Statutes Section 28-7046, recommending the abandonment of portions of State Route 101 Loop within the above referenced project.

The portions of right of way to be abandoned are depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, PRICE FREEWAY, Project 600-1-729 / 101LMA058H083302R."

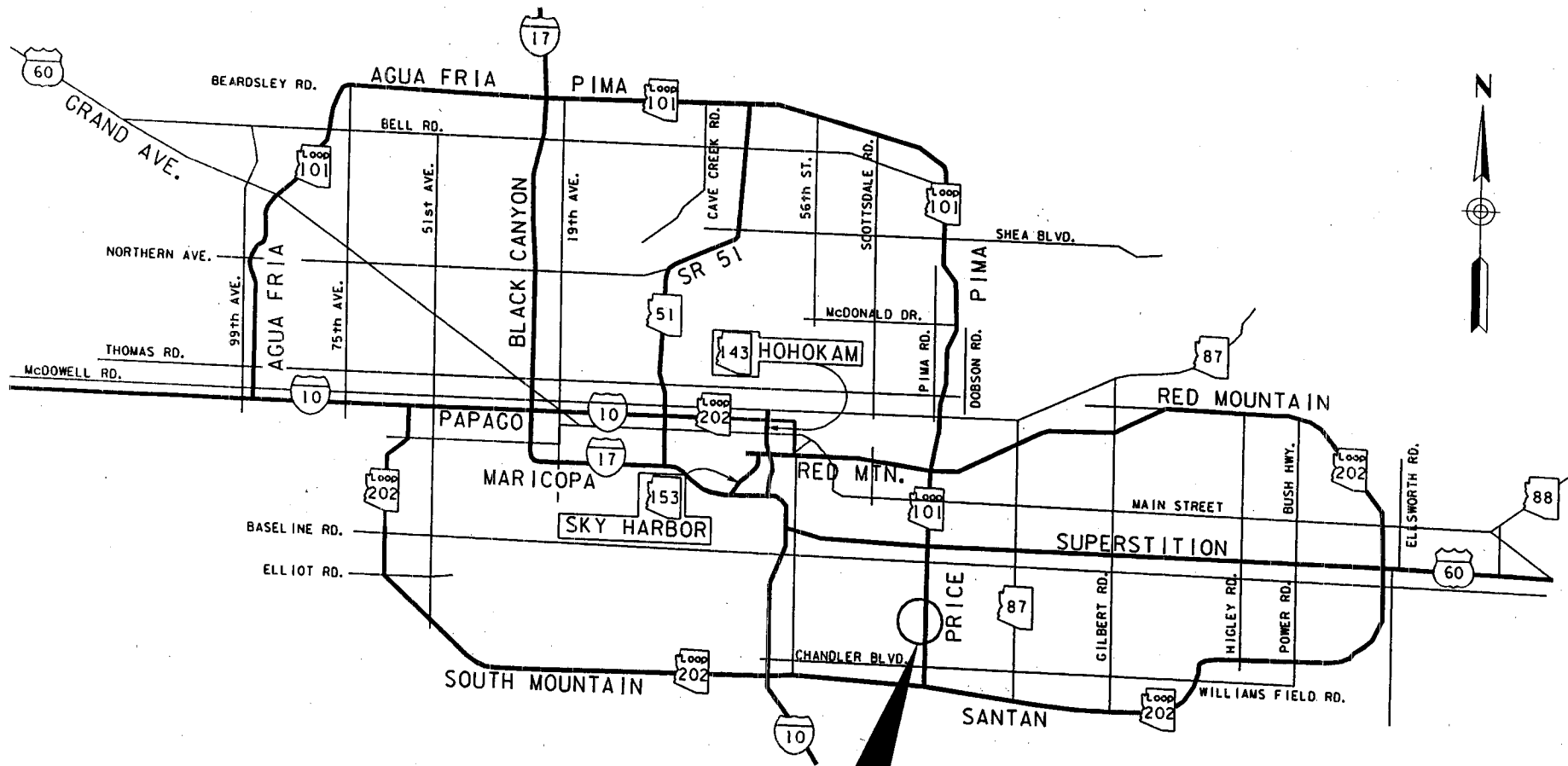
WHEREAS said portions of right of way are no longer needed for State highway purposes; and

WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

RESOLVED that the portions of right of way depicted in Appendix "A" are hereby removed from the State Highway System and abandoned to Maricopa County as provided in Arizona Revised Statutes Sections 28-7207 and 28-7209, and effective upon recordation in the Office of the County Recorder in accordance with Arizona Revised Statutes Section 28-7213; be it further

RESOLVED that the Director provide written notice to Maricopa County evidencing the abandonment of the State's interest.

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of portions of right of way acquired for State Route 101 Loop within the above referenced project.

This portion was previously established as a State Route, designated State Route 117, by Arizona Transportation Board Resolution 85-04-A-35, dated April 26, 1985; Resolution 87-08-A-77, dated August 21, 1987, refined this State Route Plan; Resolution 87-11-A-105, dated December 18, 1987, redesignated State Route 117 to State Route 101 Loop; and Resolution 98-05-A-013, dated May 15, 1998, established this portion of said route as a State Highway.

Portions of the previously acquired right of way are no longer needed for state transportation purposes. Maricopa County has agreed to accept jurisdiction of the right of way. Accordingly, I recommend that the State's interest in these portions of right of way be abandoned.

The portions of right of way to be abandoned are depicted in Appendix "A" and delineated on the maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, PRICE FREEWAY, Project 600-1-729 / 101LMA058H083302R."

I further recommend that the portions of right of way depicted in Appendix "A" be removed from the State Highway System and abandoned to Maricopa County.


