RESOLUTION OF ABANDONMENT

VICTOR M. MENDEZ, Director, Arizona Department of Transportation, on September 20, 2002, presented and filed with this Transportation Board his written report under Arizona Revised Statutes Section 28-7046, recommending the abandonment of a portion of State Route 101 Loop within the above referenced project.

The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, AGUA FRIA FREEWAY, Project 600-0-701 / 101LMA002H081103R 600-0-702 / 101LMA007H080703R."

WHEREAS said portion of right of way is no longer needed for State highway purposes; and

WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

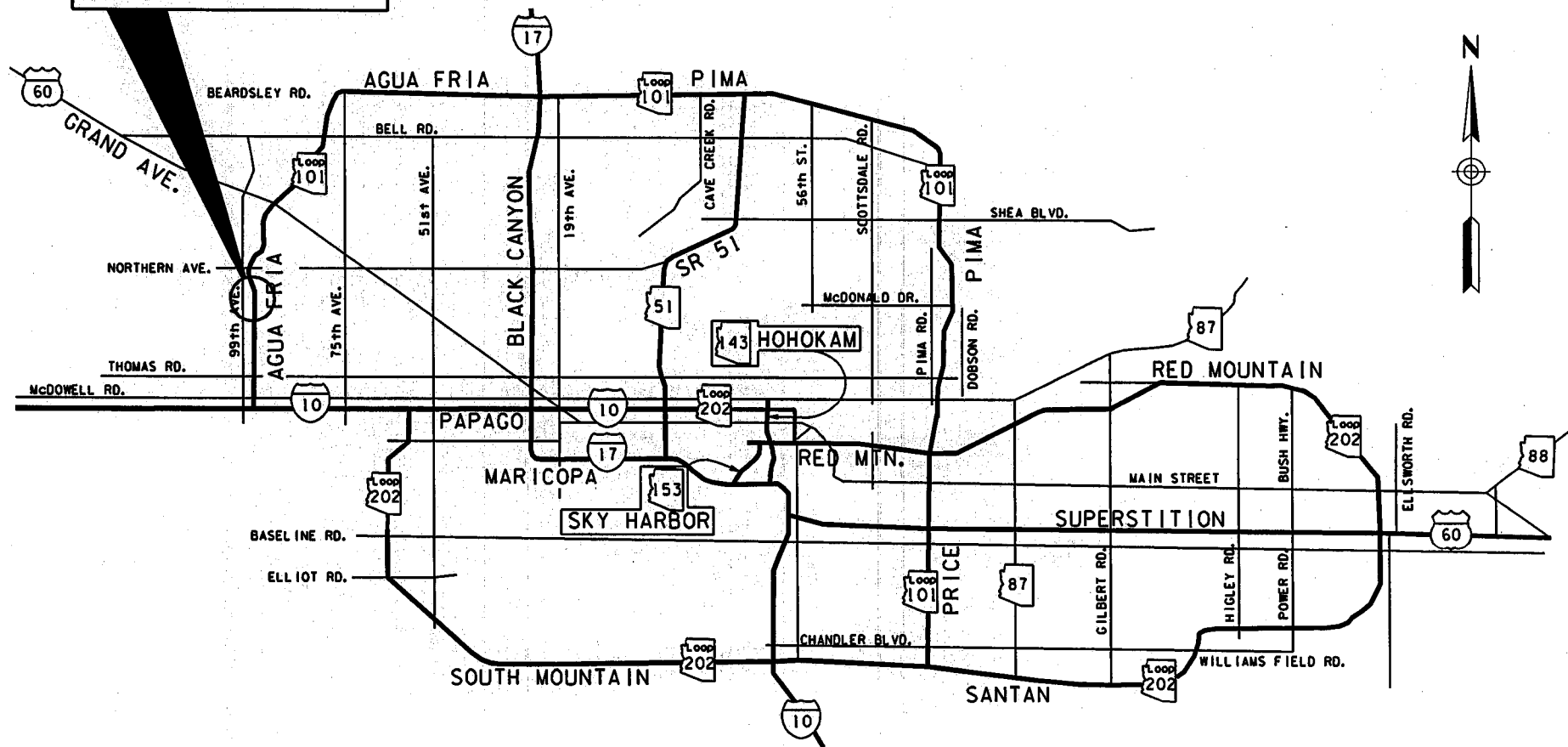

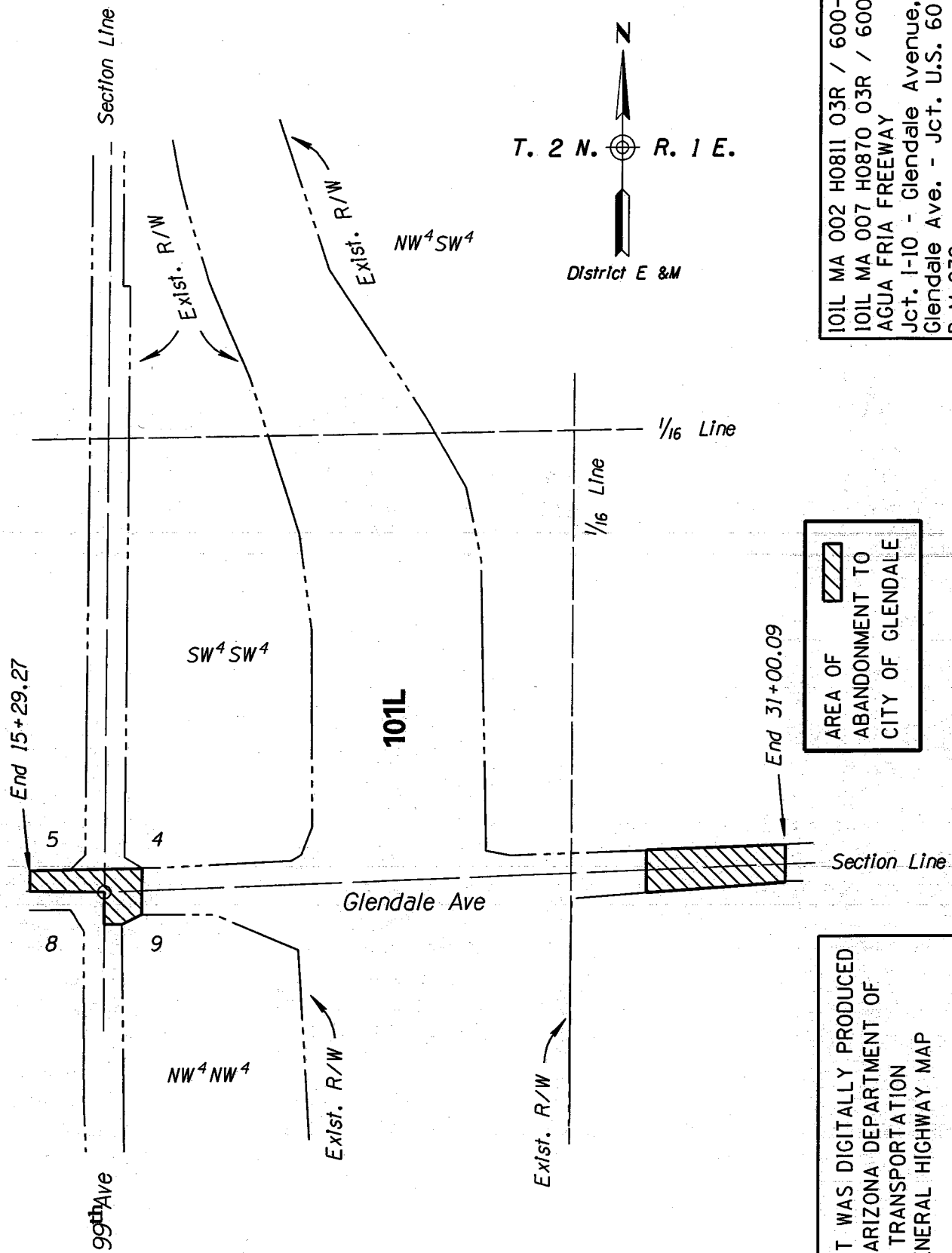

## GLENDALE AVENUE – EAST

A parcel of land located in Sections 4 and 9, Township 2 North, Range 1 East, Gila and Salt River Meridian, Maricopa County, Arizona, described as follows:

Commencing at a Maricopa County Highway Department (MCHD) brass cap in handhole marking the South quarter corner of said Section 4, which bears North  $88^{\circ}08'03''$  East 2642.07 feet from a MCHD brass cap in handhole marking the Southwest corner of said Section 4;

thence along the South line of said Section 4, South  $88^{\circ}08'03''$  West 721.10 feet, to the POINT OF BEGINNING;

thence South  $1^{\circ}51'57''$  East 55.00 feet to the South right of way line of Glendale Avenue;

thence along said South right of way line, South  $86^{\circ}06'52''$  West 598.61 feet;

thence continuing along said South right of way line, South  $62^{\circ}32'34''$  West 4.76 feet;

thence continuing along said South right of way line, North  $1^{\circ}51'57''$  West 23.16 feet;

thence continuing along said South right of way line, South  $88^{\circ}08'03''$  West 121.47 feet;

thence North  $1^{\circ}51'57''$  West 110.00 feet to the North right of way line of Glendale Avenue;

thence along said North right of way line, North  $88^{\circ}08'03''$  East 724.00 feet;

thence along the South line of said Section 5, South 87°36'14" West 238.75 feet;

thence North 2°23'46" West 65.00 feet to the North right of way line of Glendale Avenue;

thence along said North line, North 87°36'14" East 146.48 feet;

thence continuing along said North line, North 87°51'44" East 180.09 feet;

thence continuing along said North line, North 88°08'03" East 333.75 feet;

thence South 1°51'57" East 120.00 feet;

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of a portion of right of way acquired for State Route 101 Loop within the above referenced project.

This portion was previously established as a State Route, designated State Route 417 by Arizona Transportation Board Resolution 84-08-A-46, dated August 24, 1984; Resolution 86-04-A-26, dated April 18, 1986 established said route as an access controlled State Highway; Resolution 87-11-A-105, dated December 18, 1987, redesignated State Route 417 to State Route 101 Loop; and Resolution 98-06-A-021, dated June 19, 1998 established additional right of way.

A portion of the previously acquired right of way is no longer needed for state transportation purposes. The City of Glendale has agreed to accept jurisdiction of the right of way. Accordingly, I recommend that the State's interest in the portion of right of way be abandoned.

The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on the maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, AGUA FRIA FREEWAY, Project 600-0-701 / 101LMA002H081103R 600-0-702 / 101LMA007H080703R."




