RESOLUTION OF ESTABLISHMENT

VICTOR M. MENDEZ, Director, Arizona Department of Transportation, on November 21, 2003, presented and filed with this Transportation Board his written report under Arizona Revised Statutes Section 28-7046, recommending the establishment of a portion of the state route preliminary transportation corridor of the Oracle Jct. - Florence Highway, State Route 79, as a state highway.

The portion of right of way to be established as a State Highway is depicted in Appendix "A", and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, ORACLE JCT. - FLORENCE Highway, Project S-079-A-700 / 079PN127H08301R."

WHEREAS the corridor is ready for construction; and

WHEREAS construction by the Department cannot begin until the state route preliminary transportation corridor is established as a state highway; and

WHEREAS because of these premises, this Board finds that the public safety, necessity and convenience require the recommended improvement of the highway, as delineated on the maps and plans; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made a part of this resolution; be it further


RESOLVED that the right of way as depicted is designated a state highway; be it further

RESOLVED that the Director is hereby authorized to acquire by lawful means, including exchanges, in accordance with Arizona Revised Statutes Section 28-7092, an estate in fee, or such other interest as is required, including material for construction, haul roads, and various easements in any property necessary for or incidental to the improvements as delineated on said maps and plans; be it further

RESOLVED that the Director secure an appraisal of the property to be acquired and that necessary parties be compensated. Upon failure to acquire said lands by other lawful means, the Director is authorized to initiate condemnation proceedings.





REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation, concerning the establishment of the state route preliminary transportation corridor for the Oracle Jct. - Florence Highway, State Route 79, as a state highway within the above referenced project.

This portion was previously established as a state route by Arizona Transportation Board Resolution 2003-06-A-031, dated June 20, 2003 for intersection improvements.

Said state route corridor is now ready for construction and must be established as a state highway. Accordingly, it is now necessary to establish that portion of the state route corridor of the Oracle Jct. - Florence Highway as a state highway.

The portion of right of way to be established as a state highway is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, ORACLE JCT. - FLORENCE Highway, Project S-079-A-700 / 079PN127H08301R."


In the interest of public safety, necessity and convenience, I recommend that the area depicted in Appendix "A" be established and improved as a state highway.


