RESOLUTION OF ABANDONMENT

VICTOR M. MENDEZ, Director, Arizona Department of Transportation, on February 20, 2004, presented and filed with this Transportation Board his written report under Arizona Revised Statute's Section 28-7046, recommending the abandonment of State Route 89A within the above referenced project.

The right of way to be abandoned is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, PRESCOTT - FLAGSTAFF Highway, Project 089ACN400H088801R / M-951-5-702."

WHEREAS said right of way is no longer needed for state transportation purposes and will be abandoned to The City of Flagstaff for a continued public transportation use in accordance with Intergovernmental Agreement No. 99-19, dated July 16, 1999, filed with the Secretary of State under No. 23394; and Intergovernmental Agreement No. 91-65, dated December 8, 1992, filed with the Secretary of State under No. 17257; and

WHEREAS the State reserves the right to enter and maintain the bridge structures and appurtenances for Interstate Route 40 within the S.R. 89A right of way being abandoned herein; and

WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made part of this Resolution; be it further



RESOLVED that the State reserves the right to enter and maintain the bridge structures and appurtenances for Interstate Route 40 within the S.R. 89A right of way being abandoned herein; be it further

RESOLVED that the Director provide written notice to The City of Flagstaff evidencing the abandonment of the State's interest, and the action approved herein.



REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of right of way acquired for State Route 89A within the above referenced project.

This portion of State Route 89A was previously established as a state route and state highway by various Resolutions of record.

A portion of the previously acquired right of way is no longer needed for state transportation purposes. The City of Flagstaff has agreed to accept jurisdiction of the right of way in accordance with Intergovernmental Agreement No. 99-19, dated July 16, 1999, filed with the Secretary of State under No. 23394, and Intergovernmental Agreement No. 91-65, dated December 8, 1992, filed with the Secretary of State under No. 17257.

Accordingly, I recommend that the State's interest in the right of way be abandoned to the City for a continued public transportation use. The State reserves the right to enter and maintain the bridge structures and appurtenances for Interstate Route 40 within the S.R. 89A right of way being abandoned herein.

The right of way to be abandoned is depicted in Appendix "A" and delineated on the maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, PRESCOTT - FLAGSTAFF Highway, Project 089ACN400H088801R / M-951-5-702."

I further recommend that the right of way depicted in Appendix "A" be removed from the State Highway System and abandoned to The City of Flagstaff, and that the State reserves the right to enter and maintain the bridge structures and appurtenances for Interstate Route 40 within the S.R. 89A right of way being abandoned herein;

All other rights of way and easements and appurtenances thereto subject to the provisions of Arizona Revised Statutes Section 28-7210 shall continue as they existed prior to the disposal of right of way depicted in Appendix "A".

Pursuant to Arizona Revised Statutes Section 28-7046, I recommend that the Transportation Board adopt a resolution making this recommendation effective.


