RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

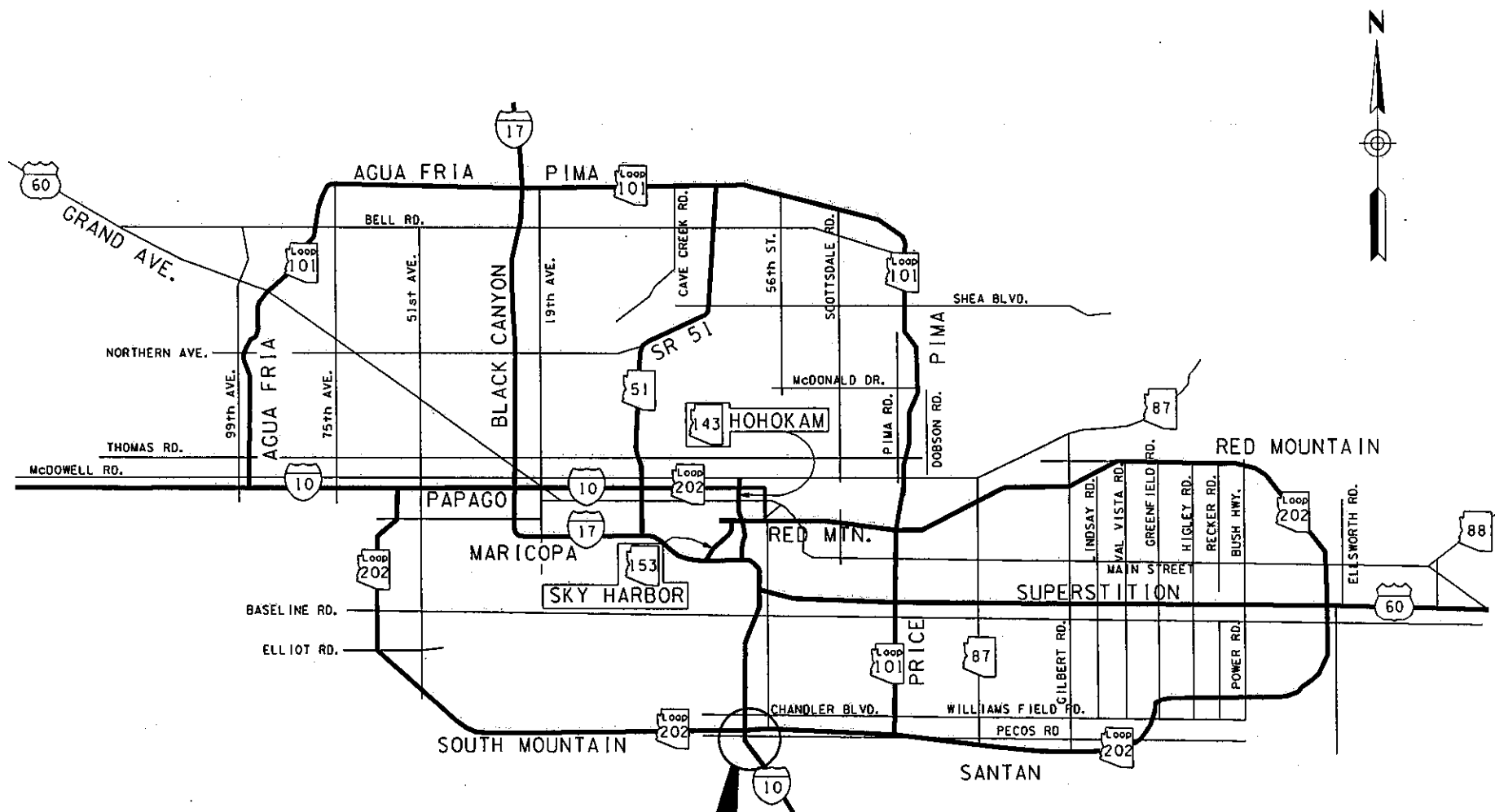
