The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, SANTAN FREEWAY, Project 600-7-802 / 202LMA000H538001R."

WHEREAS said portion of right of way is no longer needed for state transportation purposes; and

WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

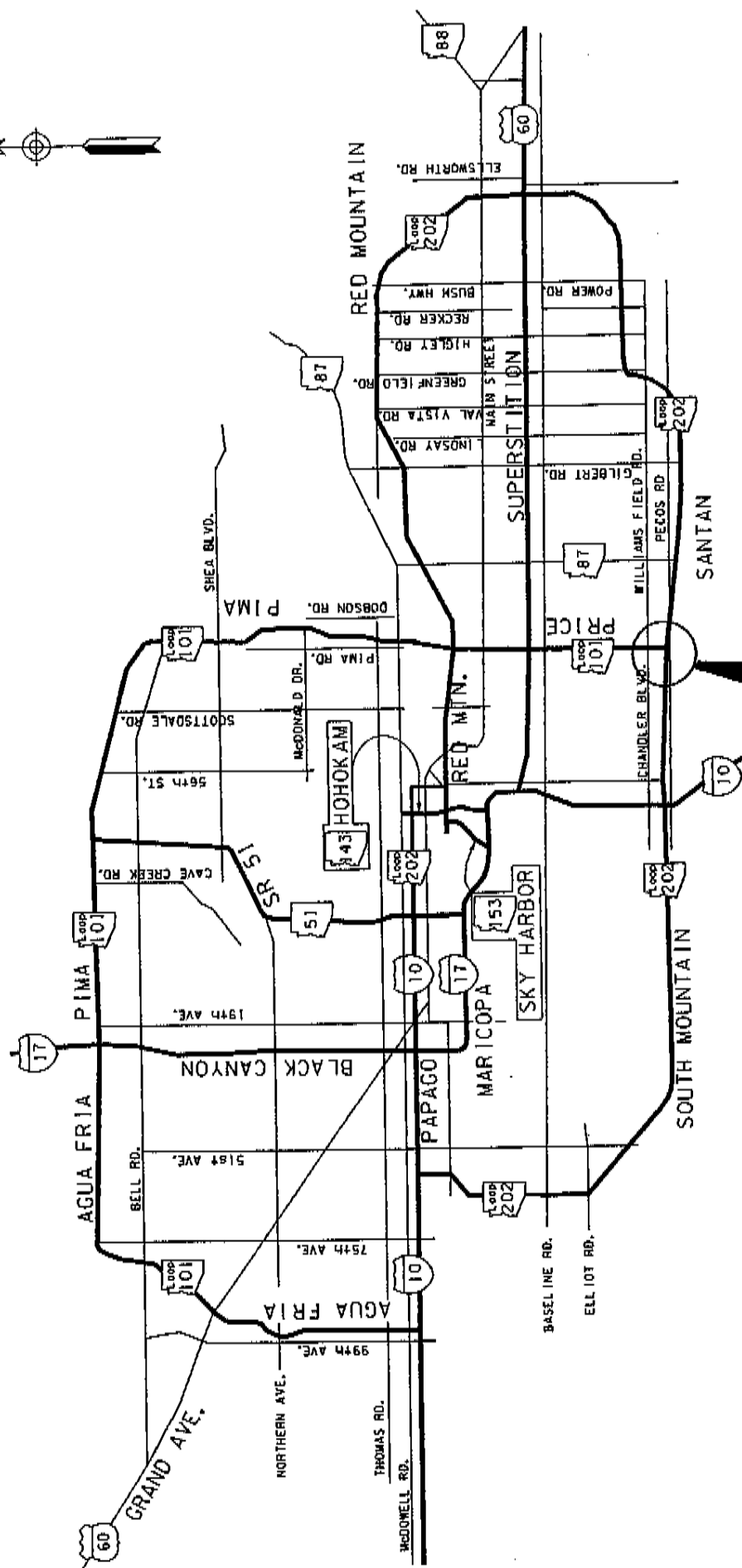
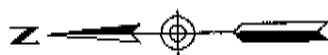
RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

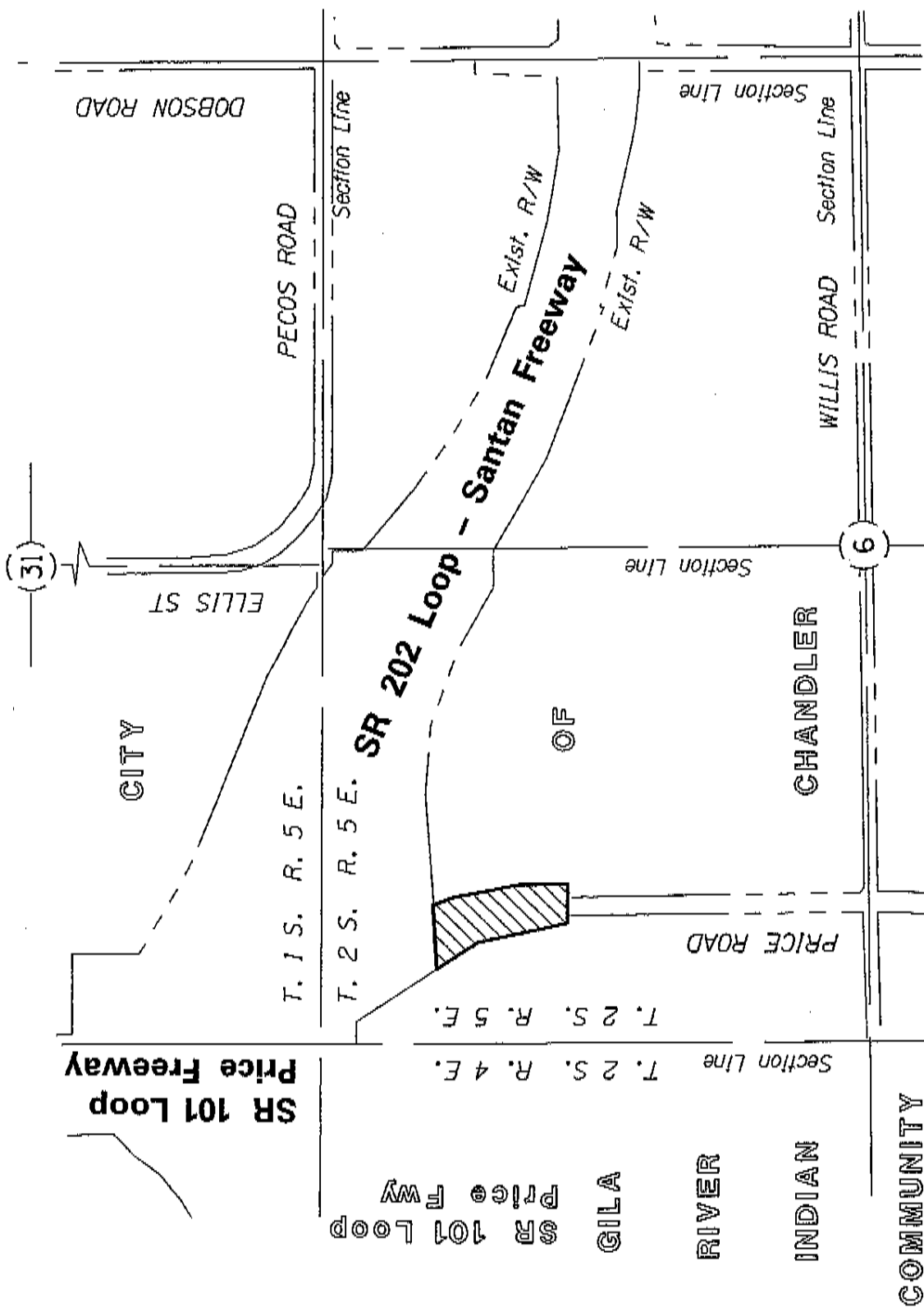

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of a portion of right of way acquired for a portion of State Route 202 Loop within the above referenced project.

This portion was previously established as a Preliminary Transportation Corridor for the Southeast Loop Freeway designated State Route 220 by Arizona Transportation Board Resolution 85-04-A-34 dated April 26, 1985; Resolution 87-11-A-105 dated December 18, 1987, redesignated and renumbered State Route 220 to State Route 202 Loop; Resolution 87-12-A-115 dated December 18, 1987, established a refined portion of the State Route Plan; Resolution 89-01-A-06 dated January 16, 1989, refined the Corridor further and authorized advance acquisition; and Resolution 01-03-A-017 dated March 16, 2001, designated this portion as a state highway.

A portion of the previously acquired right of way is no longer needed for state transportation purposes. The City of Chandler has agreed to accept jurisdiction of the right of way for a continued public transportation purpose by waiving the advance four year notice of abandonment and pavement quality report in accordance with Arizona Revised Statute 28-7209. Accordingly, I recommend that the State's interest in the portion of right of way be abandoned.

I further recommend that the portion of right of way depicted in Appendix "A" be removed from the State Highway System and abandoned to The City of Chandler for a continued public transportation purpose.


