WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

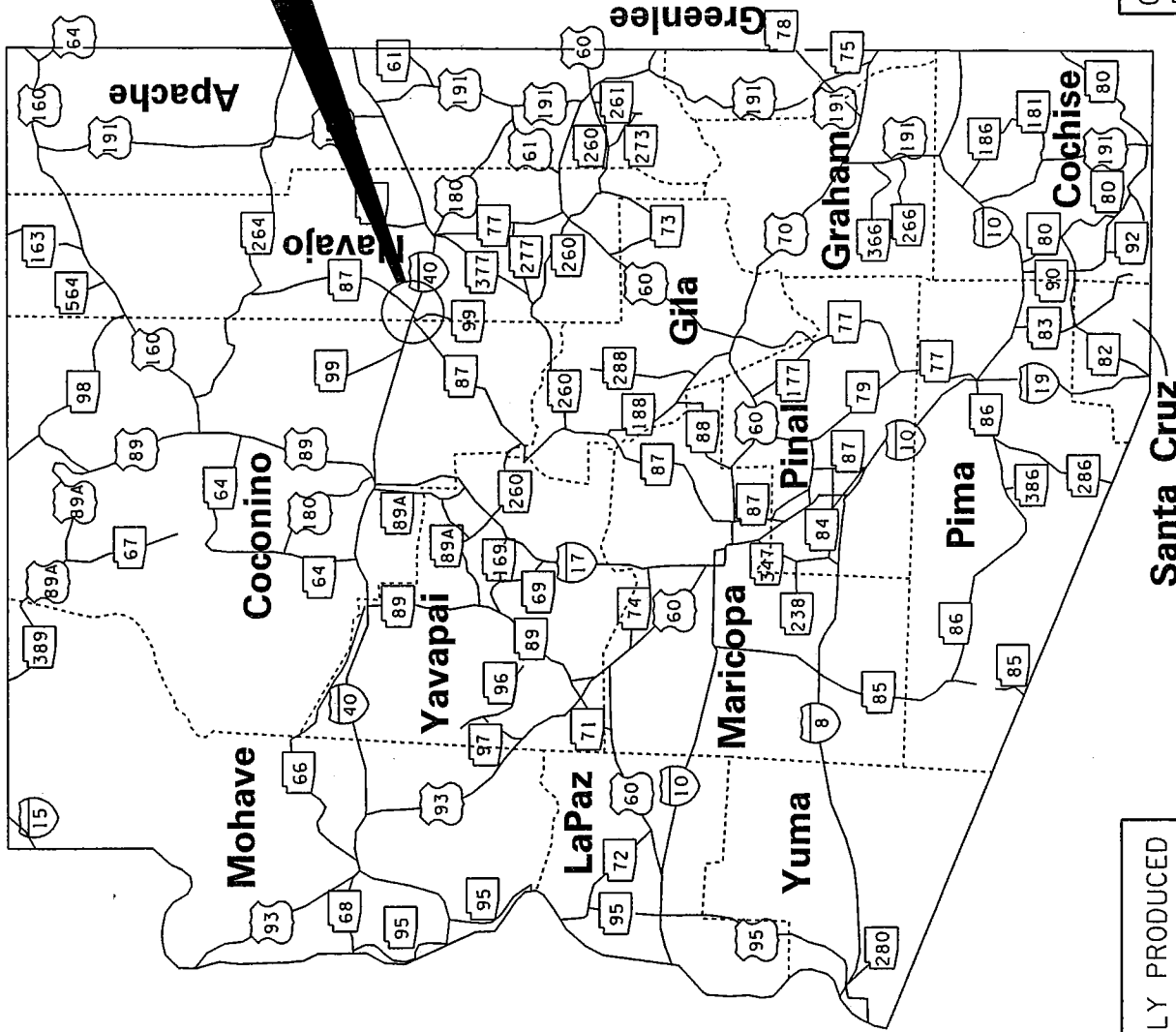
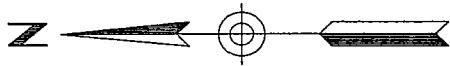

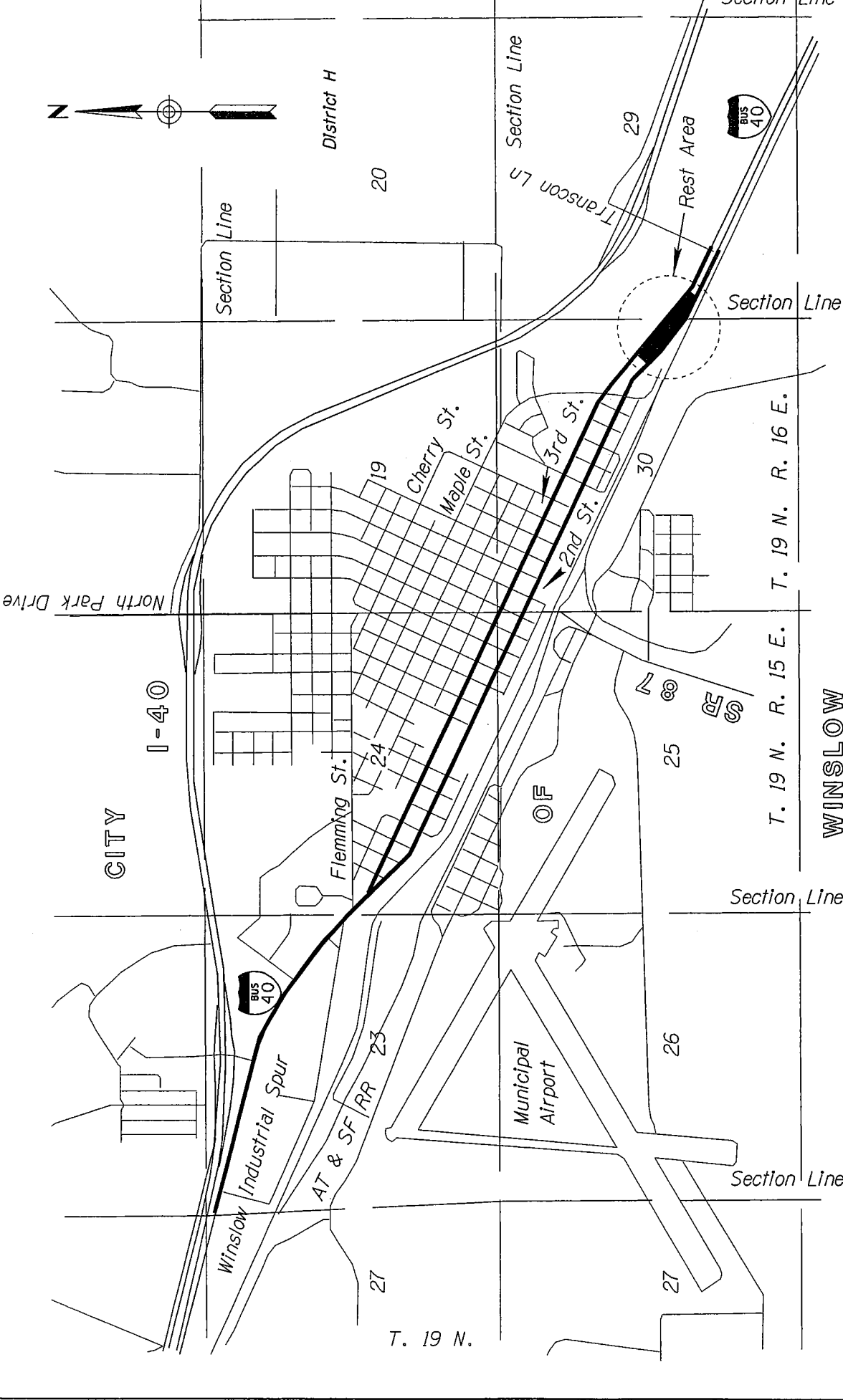

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of a portion of right of way acquired for Interstate Route B-40 within the above referenced project.

This portion was previously established by Arizona Highway Commission Resolution 67-67 dated September 26, 1967; thereafter various Resolutions established additional right of way for improvements thereof.

A portion of the previously acquired right of way is no longer needed for state transportation purposes. The City of Winslow has agreed to accept jurisdiction of the right of way, per Intergovernmental Agreement No. 03-140 dated May 12, 2005 (unrecorded) and filed with the Secretary of State No. 27513 dated May 12, 2005, for a continued public transportation use. Accordingly, I recommend that the State's interest in the portion of right of way be abandoned.

The portion of right of way to be abandoned is depicted in Appendix "A" and delineated on the maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, FLAGSTAFF - HOLBROOK Highway, Project F-008-A-810 / 040BNA000H088801R."

I further recommend that the portion of right of way depicted in Appendix "A" be removed from the State Highway System and abandoned to The City of Winslow.
