RESOLUTION OF ABANDONMENT

JOHN S. HALIKOWSKI, Director, Arizona Department of Transportation, on May 21, 2010, presented and filed with this Transportation Board his written report under Arizona Revised Statutes Section 28-7046, recommending the abandonment of Chino Valley Roads, Road 1 South, Road 2 South and Road 4 South within the above referenced project.

The right of way to be abandoned is depicted in Appendix "A" and delineated on maps and plans on file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, PRESCOTT - ASH FORK Highway, Project S-089-B-702 / 089YV317H670101R."

WHEREAS said right of way is no longer needed for state transportation purposes; and

WHEREAS the Town of Chino Valley has agreed to accept jurisdiction of the right of way, executing Intergovernmental Agreement No. 08-020-I, dated July 18, 2008; and

WHEREAS this Board finds that public safety, necessity and convenience will be served by accepting the Director's report; therefore, be it

RESOLVED that the recommendation of the Director is adopted and made part of this resolution; be it further

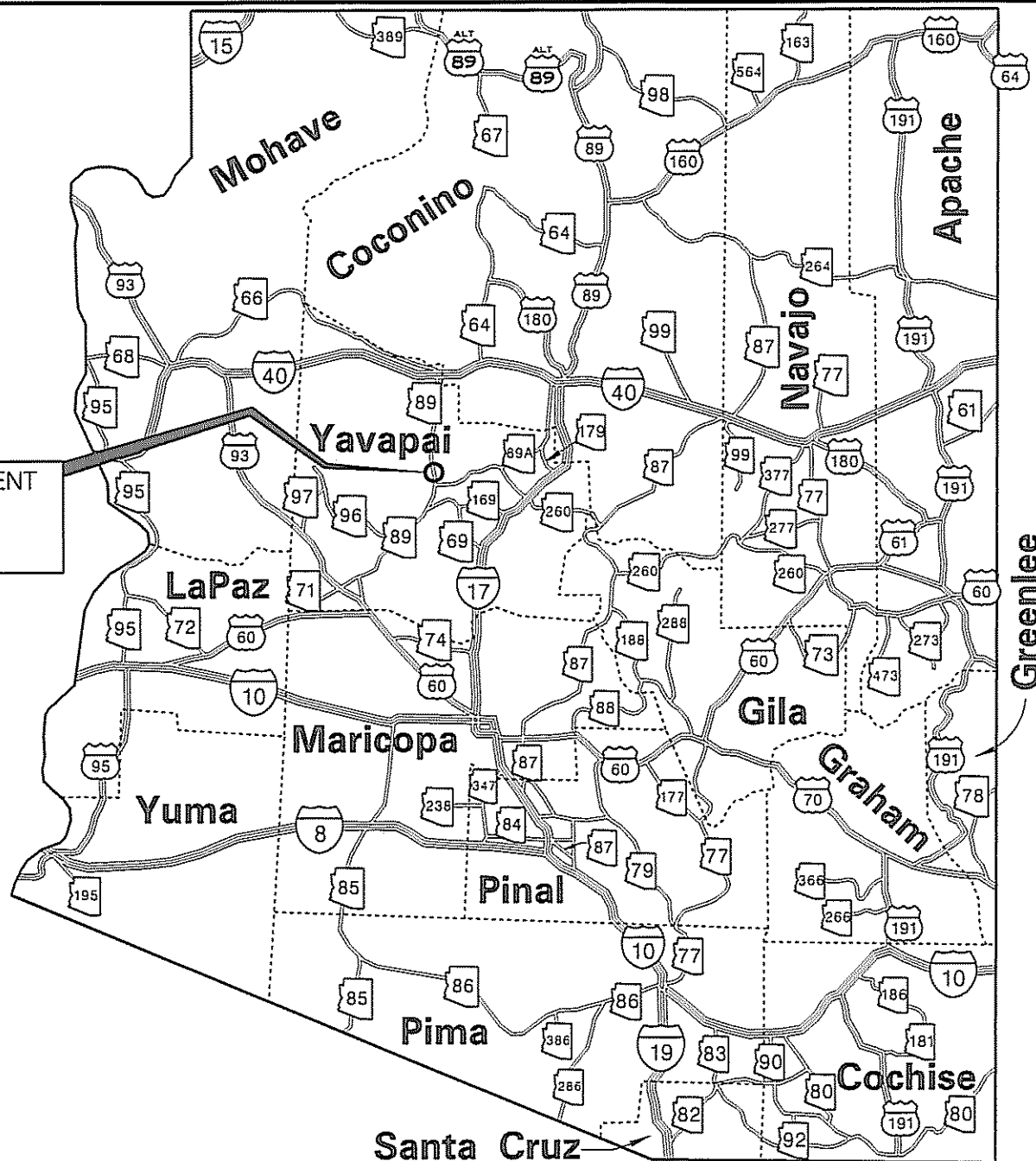

RESOLVED that the Director provide written notice to the Town of Chino Valley evidencing the abandonment of the State's interest.

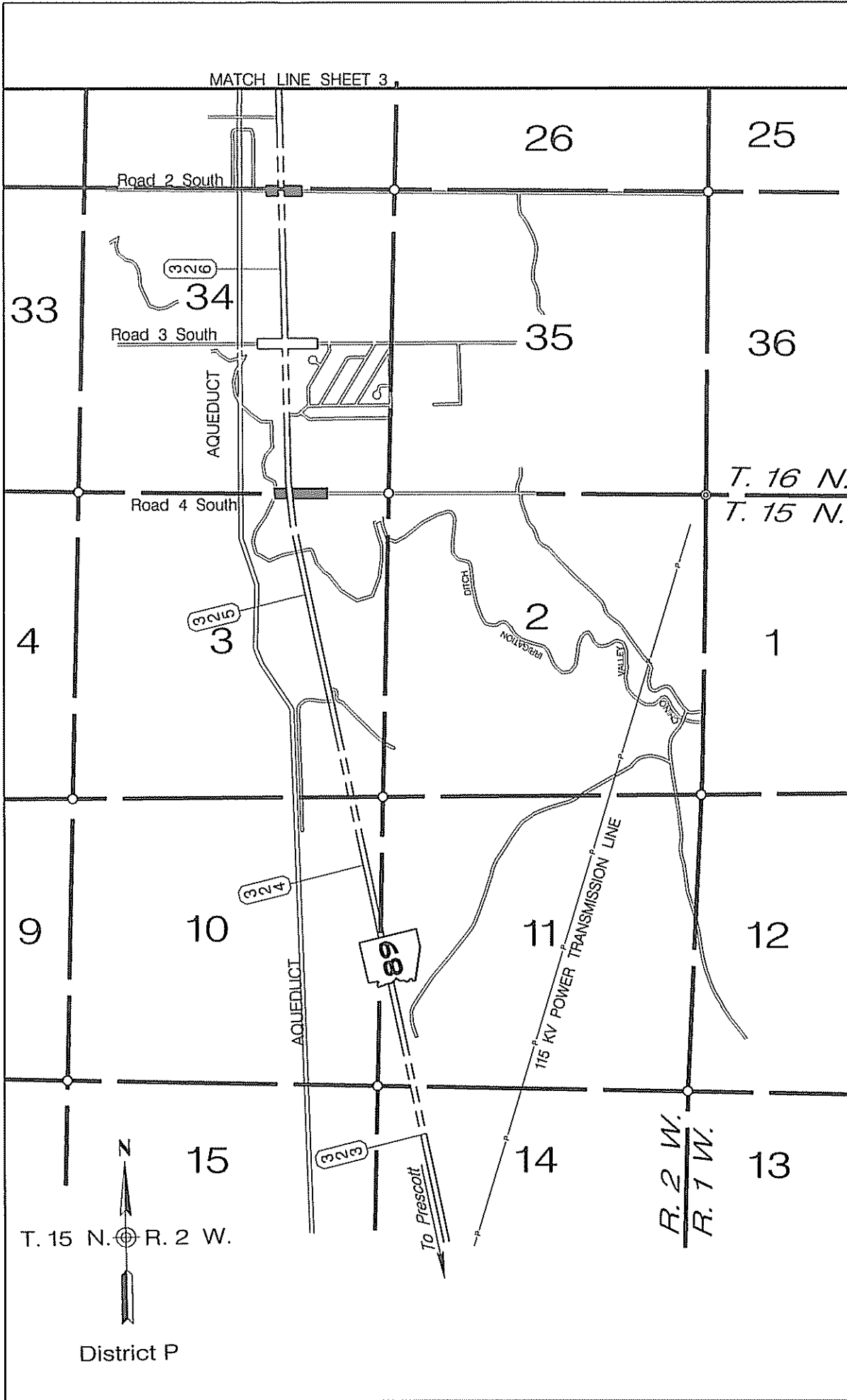

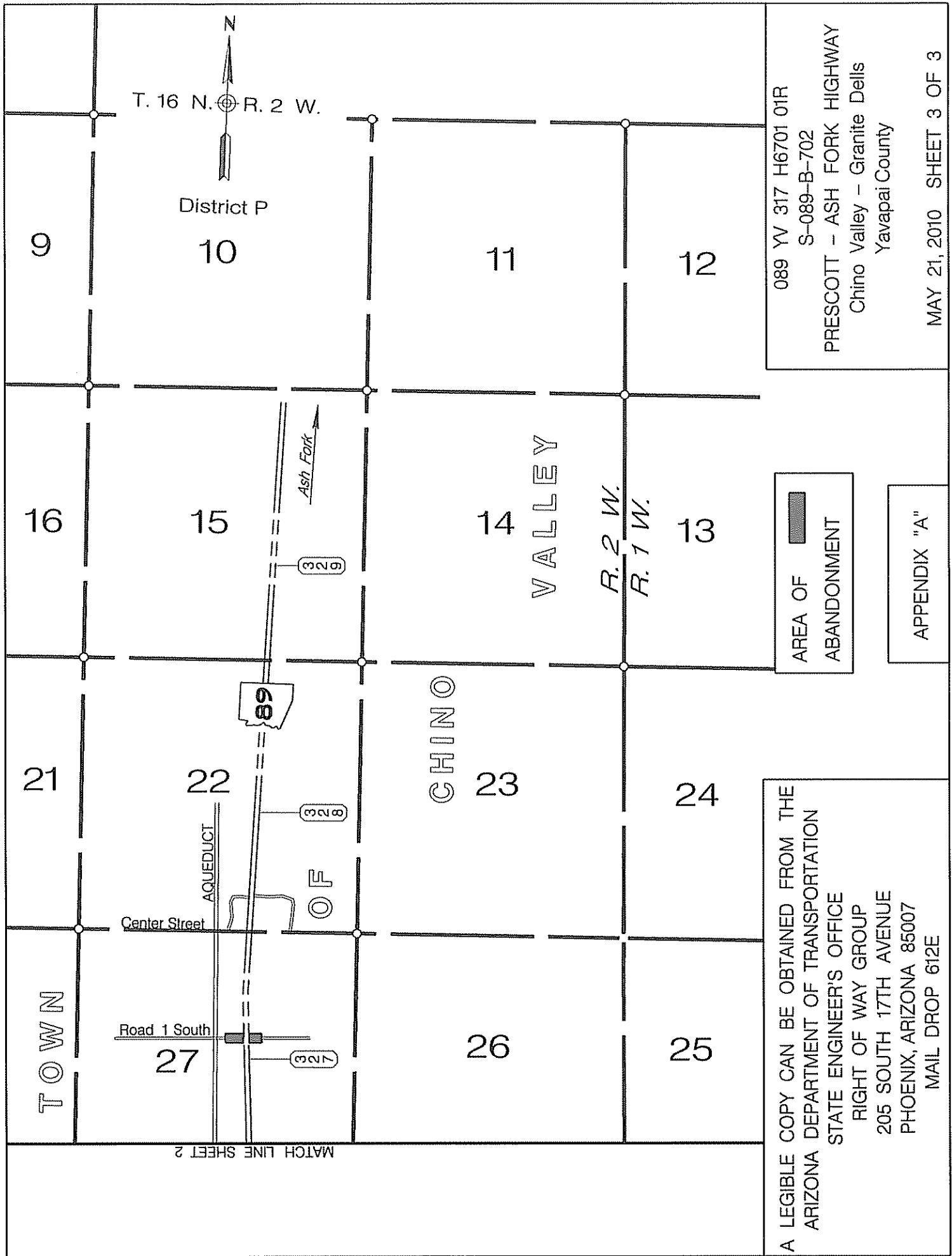

REPORT AND RECOMMENDATION

TO THE HONORABLE ARIZONA TRANSPORTATION BOARD:

The Intermodal Transportation Division has made a thorough investigation concerning the abandonment of various side streets used in a widening project recently completed on State Route 89 within the above referenced project.

This highway was previously established as a State Route and State Highway by Arizona Highway Commission Resolution dated September 9, 1927, page 26 of the Official Minutes; thereafter Arizona Transportation board Resolution 2007-01-A-001, dated January 19, 2007, established additional right of way for improvements; Resolution 2008-02-A-004, dated February 15, 2008, established the area as a state route; and Resolution 2008-04-A-018, dated April 18, 2008, amended Resolution 2008-02-A-004 due to design changes and additionally established the new right of way as a state route and state highway.

Various side streets established for the construction project are no longer needed for state transportation purposes. The Town of Chino Valley has agreed to accept jurisdiction of the side streets by executing Intergovernmental Agreement No. 08-020-I, dated July 18, 2008. Accordingly, I recommend that the State's interest in the portions of right of way be abandoned.

The right of way to be abandoned is depicted in Appendix "A" and delineated on the maps and plans is file in the office of the State Engineer, Intermodal Transportation Division, Phoenix, Arizona, entitled "Right of Way Plans, PRESCOTT - ASH FORK Highway, Project S-089-B-702 / 089YV317H670101R."

I further recommend that the right of way depicted in Appendix "A" be removed from the State Highway System and abandoned to the Town of Chino Valley.

All other rights of way and easements and appurtenances thereto subject to the provisions of Arizona Revised Statutes Section 28-7210 shall continue as they existed prior to the disposal of right of way depicted in Appendix "A".

Pursuant to Arizona Revised Statutes Section 28-7046, I recommend that the Transportation Board adopt a resolution making this recommendation effective.


